- 1. Budget for 2024 to be voted on at January Assembly (handout with adjustment to reflect increased costs for translations, etc.)
- 2. Final Report 73rd General Service Conference can see online at aa.org search for conference report and you will pull up the redacted public copy. Items of interest:

 - Plain Language version of the Big Book p. 30
- 3. Founder's Language changes issue (for example recent 12&12 change)
- 4. Requests for stories from those who have or have worked with AAs with neurological differences. Also looking for stories for revised pamphlets Native American and *Do You Think You are Different?*
